
### It really is an emergency

### **SEA CHANGE IN THE DESERT**

Utah climate conversation has radically changed in the past decade, but there is more to do.

- **2010** HJR 12 Utah Legislature declares Climate Change a hoax.
- 2018 HCR 07 Legislature calls for Utah solutions to the changing climate.
- 2020 Legislature pays \$200K for a Roadmap to Climate and Clean Air Solutions, but does nothing with it.



# Utah

### LWVUT JOINS "ALL HANDS ON DECK"

- 2018 LWVUS members rate Climate highest priority. We start fighting a polluting project near poor neighborhoods.
- 2019 Lobbied for state carbon tax with aid to rural economy. Worked for 100% Renewable Energy by 2030. Added Natural Resource Director to Board. Sent observer to COP25.
- 2020 NR Committee empowered to help amplify constituent dialog with lawmakers.

 Our Coastal and Nearshore Study informs legislators and League members allive, helping Oregonians to make the best decisions possible about the health of our coastal waters.





- 2020 Leg Session Republican Walk-Out → Governor Brown's 14 Climate Executive Orders
- LWVOR & LWVUS jointly support state & federal Civil Rights Lawsuits: Our Children's Trust 'Juliana v U.S.'

#### LWV Oregon & LWV U.S. IN THE COURT ROOM – CIVIL RIGHTS

US District Court Federal Judge Ann Aiken on a Nov 2016 decision: "I have no doubt that the right to a climate system capable of sustaining human life is fundamental to a free and ordered society." <u>Citing the League's brief</u>, "...Thus, as amicus the League of Women Voters persuasively argues, the youth plaintiffs' claims are similar to the Baker claims because they are "rooted in a 'debasement of their votes' and an accompanying diminishment of their voice in representational government."



### Four Local Leagues Advocate Against Jordan Cove Energy Project

- Proposed 230-mile natural gas pipeline & liquefaction/ export facility would span four LL areas, posing serious threats to natural & human environment, including climate
- League positions based on studies OPPOSE
- 2017-2020 Joint Advocacy Action
  - Researched issues & regulatory foundations
  - Wrote & jointly submitted 7 substantive, technical comments to state & federal permitting authorities, plus 4 key issue communications
  - · Collaborated with community allies
  - Maintained relationships &/or provided input to: state agency personnel, Governor's Office, and federal entities






# Change in Economic Growth and Emissions 2008-2018



#### REGIONAL GREENHOUSE GAS INITIATIVE ELECTRIC SECTOR

- Emissions from electricity sector down 50% in MA
- CO<sub>2</sub> emissions down 90% faster in RGGI states than rest of country
- 31% greater economic growth than rest of country at same time
- Almost \$4B in regional revenue generated
- Revenue invested in energy efficiency programs in MA to further reduce emissions





#### Tackling the Transportation Sector Transportation & Climate Initiative

- Transportation largest emitter: 43%
- Replicate success of RGGI cap and trade in transportation sector

### Five Years... then Success

League plays critical role in Virginia joining RGGI in 2020


- Laid groundwork over five sessions of Virginia's legislature
- Coordinated constituent meetings with legislators back home in their districts
  - Partnered with environment organizations to prepare the constituent delegations for their meetings.

Virginia is the first southern state with carbon cap & trade

#### **FLORIDA LWV MEMBERS TAKE ACTION**

#### Local Leagues Increase League's Nonpartisan Voice for Climate Action

- Declaration of Climate Emergency
- Mobilization for Collective Action
- Action Motion
  - An Action Motion is a motion that **requires** action by the League to a government official agency or body.
- Resolution calling for Political Action
  - "... Climate change has a disproportionate effect on communities who typically have fewer resources for adapting to climate change and so consequently are the most vulnerable to displacement, adverse health effects, job loss, property damage and other effects of climate change...."



# Florida

### **Nine Local Leagues are Signatories**

IMPLEMENTATION IN ACTION

"We as delegates of Florida local Leagues assembled at the 2019 LWVFL Convention call upon the LWVFL Board for action which shall include sending the Climate Emergency Resolution to the Governor, all members of the Florida Cabinet, the President of the Senate and Speaker of the House, as well as encouraging local Leagues to advocate for the Climate Emergency Declaration and relevant action by county and local governments. "


